Syncrobot — Terms & Conditions

Effective Date: 1 August 2025

1. Introduction

Welcome to Syncrobot. These Terms & Conditions ("Terms") govern your access to and use of the Syncrobot platform, tools, software, services, and related applications (collectively, the "Service"). By creating an account, accessing, or using the Service you agree to be bound by these Terms. If you do not agree, do not use the Service.

2. Definitions

- "We", "Us", "Our" Syncrobot and its affiliates.
- "You", "User" any person or entity using the Service.
- "Bundler Wallets" wallets that perform bundled token buys as part of Syncrobot features.
- "Volume Wallets" wallets that perform programmed volume buys/sells as part of Syncrobot features.
- "Tools" any feature provided by Syncrobot, including bundler, volume, sniper, analytics, wallet management, and any other tool.

3. Acceptance of Risk & No Guarantee of Results

You acknowledge and agree that:

- Use of Bundler Wallets, Volume Wallets, or any other Tools **does not guarantee** profitability, liquidity, token listing, price appreciation, or any particular market outcome.
- The Service only executes or coordinates actions you configure. Market conditions are unpredictable; past performance is not indicative of future results.
- You assume all risk for trades, token purchases, listings, liquidity events, and any losses arising from use of the Service.

4. No Refunds / Non-Refundable Fees / Server Maintenance

- All fees, payments, credits, subscriptions, or other charges paid to Syncrobot are non-refundable.
- Trial offers (if any) and promotional credits are subject to separate terms and may be revoked or modified at Syncrobot's sole discretion.
- If Syncrobot servers are under maintenance, upgrade, or downtime, users must wait until
 the service is restored. This includes periods that may last days, weeks, or even up to a
 month. No refund or compensation will be provided for delays caused by server maintenance
 or downtime.
